APPLICATION FOR MEMBERSHIP

The undersigned hereby makes application to RURAL WATER DISTRICT NO. 6 MUSKOGEE COUNTY OKLAHOMA, for water service at and upon the premises here in below and agree to the following conditions:

1. Purchase or cause to be purchased One Benefit Unit (meter) which is as follows: the setting of the meter, tap saddle, water line extension, engineering. Road bore, if needed, will be at the unit price of \$1,000.00. Each water meter will be set at the unit price of \$1,200.00. This will be at the expense of the applicant and installed by the water district. This Benefit Unit entitles the applicant (owner) thereof to one water line from the District's water system. Such line shall serve only one residence or business establishment together with the necessary and usual outbuildings.
 2. Applicant (property owner) agrees to assume and be bound by all of the obligations imposed upon the holder of such Benefit Unit according to the by-laws and the rules and regulations of RURAL WATER DISTRICT NO. 6, MUSKOGEE COUNTY OKLAHOMA.
 3. The Benefit Unit follows the deed of the land. All charges levied against the Benefit Unit must be paid before it can be transferred to a new owner. The Benefit Unit cannot be transferred to another location without the approval of the Board of Directors of RURAL WATER DISTRICT NO. 6.
 4. Receipt of \$1,200.00 or \$2,200.00 (with road bore) will constitute a subscription for water service. This consideration paid for this Benefit Unit is a membership to RURAL WATER DISTRICT NO. 6 and is in no event refundable to subscriber. It is further agreed that the undersigned shall diligently undertake to have his/her premises prepared for service within 60 days of the signing of this agreement, if such is not now installed, so that he/she shall be in a position to use the service. After that date the subscriber shall commence payment for service or forfeit his/her option.
 5. Applicant is to contact the DEQ (1-405-702-8100) for soil percolation test before installing a sewage system. Applicant further agrees that water will not be plumbed to any dwelling for household use until final inspection by the DEQ has been made on the sewage system installation before covering the system.
 6. Payment of the month's water bill is to be made no later than the 16th day of the month. Bills not paid by the 16th day of the month shall be subject to a late charge of \$25.00, which will be applied to your overall billing. The Benefit Unit is subject to be cut off if not paid by the 16th day of the following month. In the event of a cut-off, there is a \$100.00 reset fee. If no payment has been made within 6 (six) months the meter will be pulled and terminated/forfeited; the membership WILL be treated as a new membership and charged as such.
 7. The operator will clearly mark the location of the meter. The water meter will be installed adjacent to the property owned by said applicant's access point as close to the main water line and public road as possible. This location is normally next to the driveway to allow for easy access for the purpose of reading the meter.
 8. The property owner is responsible for the legal description of setting the meter on the correct property and therefore agrees to furnish a copy of the deed to prove ownership of said property and an easement must be signed by the landowner allowing the water district to repair or replace meter and water lines. If at a later date the meter is found not to be on applicant's property, the meter will be moved at owner's expense.
